## THE ETHICAL CODE OF THE JOURNAL

The authors, reviewers, and editors abide by the following ethical code of the journal of *Forensic Engineering*:

### Declaration of the ethics of publishing

Forensic Engineering is a reviewed journal published by Akademické nakladatelství CERM, s.r.o. Brno in cooperation with the Institute of Forensic Engineering of Brno University of Technology. The following text expresses the standards of ethical behaviour of all the participants in the publishing of articles in this journal. The guidelines are based on The Best Practice Guidelines for Journal Editors of the COPE (Committee on Publication Ethics).

# **The author** proclaims that:

- he/she has submitted his/her original work;
- he/she is not publishing the same manuscript or a very similar one or a manuscript with the same title in more than one journal. Papers that were previously partly published in a symposium or conference proceedings or in a qualification project (seminar projects, bachelor or master degree projects, theses, dissertations, etc.) can be accepted for publication. Such an exception can be made only if the author of the paper informs the editors in advance of the fact that the paper has been published elsewhere and mentions this fact in the paper;
- he/she has properly quoted all the papers or words of another author mentioned in the manuscript;
- he/she has made sure that the paper mentions all the co-authors who have approved of the final version and agree with the submission and publication of the manuscript;
- he/she has made sure that the list of authors does not include anybody who has not participated in the creation of the article;
- he/she will immediately inform the chief editor if he/she finds a significant mistake or inaccuracy in their manuscript and will help with its withdrawal or correction;
- he/she is aware of the fact that deceptive or intentionally inaccurate statements as well as plagiarism in all its forms constitute unethical behaviour and are unacceptable.

## **The chief editor** proclaims that:

- he/she is responsible for the decision about whether the submitted manuscript will be published in the journal;
- he/she follows the policy of the editorial board and the effective legal regulations if slander, copyright infringement or plagiarism occur;
- he/she can consult the editorial board or the reviewers about their decisions;
- he/she cannot make any information on a submitted manuscript available to anyone else than the author, reviewers, potential reviewers, other editorial consultants or the publisher;
- the manuscripts are only assessed based on their professional value.

#### The reviewer proclaims that:

- he/she writes the reviews objectively; expresses his/her opinions clearly with soundly based and appropriate arguments;
- considers each manuscript a confidential document and does not show it or discuss it with non-participating persons;
- if he/she finds out about any violation on the author's part such as copyright infringement or plagiarism, he/she will immediately inform the chief editor;
- he/she will refuse to review a manuscript which could pose a conflict of interest;
- he/she will inform the chief editor if he/she does not feel qualified enough to review a manuscript.
